- AFID (VA Department of Ag) Planning Grant of \$20,000 Economic Development Department will fund \$2,000.00, asking the EDA to fund \$4,000.00 and the state will fund \$12,000.00.
 - Motion to fund \$4,000.00 to AFID Grant provided that this board can receive regular updates, that we can have a half way point where this is a substantial part of a meeting where we are giving attention to it and provided that we can have a final meeting towards the end of this project where we discuss the findings and take it on and engage with it. With those stipulations being met, I move that we allocate this funding to support the program: Alex White, seconded Jay Dedman Ayes (5) Nays (0)
- Recap Food Hub Funded \$51,768.91 to local markets and restaurants for 12 weeks during the food hub program. Shenandoah funded \$26,100.00 and the county funded \$42,829.00. \$124,000.00 was invested into the small business economy with the food hub in coordination with Page One, five people were hired to assist, 5,675 masks were made locally for distribution.
- Small Business Assistance Relief Program to date, checks written total about \$25,000.00 and helped 15 businesses so far. There is about \$450,000.00 left in the program.
- Internet Grant \$1.7 million, 6 tower projects, will need to go through the Special Use Permit Process through Planning Commission and Board of Supervisors
