# A. Campground Subcommittee Report

Ms. Grech noted that the meetings have been very productive. At the last meeting, Mr. Jeremy Baldwin attended as a representative of a current campground operator and provided valuable input. Ms. Grech noted that Ms. Yvonne Berezoski will also be participating in the committee. She is unable to attend the next scheduled meeting but plans to submit comments on the current draft document. The committee continues to work toward making recommended changes to the ordinance, including but not limited to, recreational facilities and uses, road standards, etc.

# B. Zoning Ordinance Amendments- Riding Stables or Academies and the Industrial Zoning District

Chairman Burner stated he was finally able to review Mr. Helm's comments on the proposed amendments. Due to confusion in the proposed "intensive agriculture" definition recommended by The Berkley Group, he recommended striking the definition (for the time being), and also striking the "intensive agriculture" use in the Agriculture (A-1) zoning district. He also suggested they change the definition of "meat" as recommended by Mr. Helm to read: "The tissue of an animal when used for food". He further recommended they change the word "manufactures" to "manufactured" in Section 125-13.B(5) as recommended by Mr. Helm. Lastly, he recommended the proposed amendments related to riding stables or academies remain as drafted as legal had no concerns with that. Ms. Grech made a motion to make the above-mentioned changes to the

proposed draft and recommend approval to the Board of Supervisors. The motion was seconded by Mr. Smelser. The motion passed unanimously (3-0).
